Information on the processing of personal data

Information clause

In keeping with art. 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data – general data protection regulation (Official Journal of the European Union L 119/1 of 4 May 2016), the Polish Centre of Mediterranean Archaeology University of Warsaw informs:

1. Your personal data is administered by the University of Warsaw (*the Controller*), with the headquarters in Warsaw at Krakowskie Przedmieście 26/28;

5. The provision of personal data is voluntary yet necessary for the achievement of the purposes for which they have been collected;
6. The personal data provided will not be made available to external entities, except for the cases provided for by law;
7. Your personal data will be stored by 5 years;



8. You have the right of access your personal data, as well as, subject to legal provisions, the right to correct and delete data, limit their processing, transfer them, object to processing, and withdraw consent for processing at any given time;
9. You has the right to submit a complaint to the Inspector General for the Protection of Personal Data (Polish: Generalny Inspektor Ochrony Danych Osobowych);
10. Your data will not be processed in an automated manner and will not be profiled.

Clauses of consent
