

License Agreement

THIS LICENSE AGREEMENT is made on

IT IS AGREED AS FOLLOWS:

§ 1. The Author of the scientific work: ".....", which the Author submitted to the Publisher and which the Publisher accepted for publication in the journal *Polish Archaeology in the Mediterranean*, is authorized to license the uses subject to this agreement by reason of being the author of the work in question and owning all rights necessary to grant the requisite license for the uses subject to this agreement and without imposing on the rights of third parties. The Author claims to have obtained rights to the uses subject to this agreement for all material included in the work that she/he does not own rights to and that she/he has submitted to the Publisher a list of material to which she/he does not own rights and which the Publisher is required to obtain independently. The author grants permission to the Publisher to delete any material of third party authorship, if the Publisher is unable to obtain free use of said material.

§ 2. The Author grants the Publisher a non-exclusive and non-transferable license, waiving payment, unrestricted in time and territory (covering the whole world) for all permitted uses of the licensed work referred to in § 1 in all fields of exploitation. The Publisher will have rights in particular to the following uses:

- 1) Print and copy the work in digital techniques, without limitations on the manner and form of recording the digital version;
- 2) Distribute the work in print and/or electronic form in book circulation and free distribution;
- 3) Make the work available in other ways than in 2) – public display, reproduction, reissue, communication to the public via an open network.

§ 3. 1) The name of the Author will be given in the publications in which the work will be included in accepted form for the given publication.

2) In case the work is published in a collective publication of works by different authors, the copyright on the publication will be for the Publisher alone.

3) In publications containing exclusively the work mentioned in §1 the copyright will be as follows:

§ 4. The Author will inform the Publisher of granting the rights to publish the work by a third party, submitting bibliographic data of the publication where the work was included.

§ 5. In matters not covered in this agreement the law on intellectual copyright and related laws are applicable.

§ 6. The parties agree to settle any disputes amicably and in good faith, and where it cannot be solved within reasonable time that any dispute arising out of or in connection with this License Agreement shall be subject to and within the jurisdiction of the national courts proper to the Publisher.

§ 7. Alterations to this agreement are valid only if they are recorded in writing and signed by both parties.

§ 8. The agreement is prepared in two identical copies.
